As you know from previous contacts with the school, we are concerned about the number of days of school your child has missed this year.

A school team has scheduled a meeting so they can work with you to identify the cause of these absences, discuss the impact of the absences on your child's education and, most importantly, devise a plan to improve your child's attendance at school.

Under Vermont Department of Education policy, the Burlington School District must track student attendance. The District's attendance procedures require that we notify you of student absences although you already may have discussed the absences with your child's school. Those procedures also require the school to hold a meeting after 15 absences.

If you do not attend this meeting or if your child misses another five days of school, the District could ask the Chittenden State's Attorney to seek court action.

Our intent, and the intent of Vermont state law, is to ensure students are in school and learning. School attendance is critical in successful school performance. National research suggests that student academic performance corresponds to their attendance.

We look forward to working with you at the meeting to improve your child's attendance.

This letter is to inform you that pursuant to School District Policy JEDA and its procedures, an affidavit regarding your student's excessive absences from school has been submitted to the Chittenden County State's Attorneys Office for prosecution or appropriate legal action.

A student's excessive absence from school is a violation of Vermont laws, 16 V.S.A. Section 1127 and 33 V.S.A. Section 5528. As a result, there may be a criminal prosecution and a fine of up to \$1,000 or a determination your student is in need of care and supervision with loss of custody as the most extreme consequence.
